

What is Linus Health?

Linus Health provides a computer-based system (called the **Platform**) that helps doctors and researchers give brain health tests. It is not a medical diagnosis tool by itself. These Terms explain how you're allowed to use the Platform. If you don't agree to these Terms, stop using the Platform immediately. FAILING TO ADHERE TO THESE TERMS MAY LEAD TO FINES OR STOPPING YOUR ACCESS TO THE PLATFORM.

Your Access

Linus Health gives you a limited right to use the Platform, as long as you follow their rules. This right can't be transferred or sublicensed. You're only supposed to use it to help with brain assessments for patients or study participants.

Changes to the Platform

Linus Health can make updates or changes at any time. If the changes affect how you use it, they will try to let you know.

Security

Linus Health uses security systems to protect data but aren't responsible if something goes wrong because of someone else (like the cloud provider or users themselves). They can temporarily stop access to the Platform if there is a suspected or actual security breach.

Outside Links & Devices

The Platform might link to other websites or use devices like tablets or pens. Linus Health isn't responsible for outside websites or the devices, but will pass along any warranties they received from device makers. If Linus Health provides equipment, you must take care of it, avoid damage and modifications, and return it when required.

Intellectual Property

Everything in the Platform, including software and ideas, belongs to Linus Health. You don't own it—you're just allowed to use it.



Keeping Information Private

Any confidential or private information you learn from using the Platform must be kept secret. You can't share it unless Linus Health says it's okay.

Using the Platform

You must keep your login information private and let Linus Health know if there's any security issue or if someone breaks the rules.

Personal Data

You and the participants may be asked to give personal information (like names, birthdates, or email addresses). Linus Health uses this data to run the Platform, improve its services, and send you updates or support. They'll always protect this data and keep it anonymous when used for research or improvements.

Data Use

Linus Health can use the data (after removing personal info) to study how their Platform is working and make it better.

What You're Not Allowed to Do

You can't:

- Copy or change the Platform
- Let others use your access
- Try to figure out how the system works
- Post offensive or illegal content
- Use the Platform to make a competing product



For Research or Clinical Use

If the Platform is used in a research study or with patients, you must follow all laws, including getting consent from participants. Linus Health can use anonymized data for studies, and any published results must say that the Platform was used.

Data Privacy (Especially for EU Users)

If you're in the EU, you agree that personal data might be sent to the U.S. Linus Health will follow strict European privacy rules when handling data from EU users, including keeping it secure and letting you control how it's used. If there's a data breach, they will notify you and help fix the problem.

Monitoring and Location of Data

Linus Health can check how the Platform is being used. Data might be stored in different locations around the world, but always following privacy laws.

Disclaimer

Linus Health doesn't promise the Platform will be perfect. It might have errors or go offline. They are not responsible for how it's used in medical care.

If Something Goes Wrong (Indeminification and Liability)

If someone sues Linus Health because of how you used the Platform or shared data, you may need to cover Linus Health's costs. If something bad happens while using the Platform, Linus Health won't pay more than \$10,000. They aren't responsible for lost data or money unless it's clearly their fault.

Legal Disputes

If there's a disagreement, it must be handled through arbitration in Boston, Massachusetts (or the UK if required by law). You can't take it to a regular jury trial.



Ending Your Access

Your access can end when your assessments are done or if you break the rules.
